## Skyecroft Clubhouse Rental Agreement Clean-Up Checklist

Please Note: when cleaning wood floors, light sweep only, do not mop and do not vacuum with brush spin.

KITCHEN Discard all food Remove all garbage Remove all personal items from the refrigerator Wipe down refrigerator, sink, countertops and stove Ensure ALL appliances are turned off Lightly sweep the floor

### SITTING AREAS

Discard all food
Wipe off tables and chairs
Ensure all furniture is in its original position
Remove all decorations
Lightly sweep the floor
Vacuum carpets

### **BAR AREA**

Remove all garbage
Wipe off tables and chairs
Wipe down counters and clean sink
Lightly Sweep the floor

#### **GENERAL**

- Place all garbage in trash bags, remove and dispose of all trash, immediately after the
  function is over. Place all trash in the outdoor trash containers on the left side of the
  Clubhouse behind the wooden gate. Note: if all trash is not removed your deposit will be
  forfeited.
- Turn off all lights, lock all doors and windows and return thermostat to appropriate setting 60 degrees in the colder months and 70 in the warmer months.
